To provide educational consulting and services including web/internet based education services and to conduct in India and/or abroad, orientation courses, classes, seminars, conferences, workshops, lectures, debates, contests, research, studies developing computer software, in various fields of education concerning students and all section of society and other issues of national, economic, and common interest and to arrange for imparting education, training to students and the general public and to get published all types of study material relating to such seminar, orientation courses, research studies, educational courses and training programmes, through post, through internet, audio/video cassettes or any other media/forms available .
  
  3. To provide students with the information on the educational opportunities in India and overseas in different steams of education and assisting students in getting admission in Indian and overseas educational institutions and to conduct and organize educational programmes in the Republic of India and abroad.

4. To establish maintain and conduct language classes, educational institutions and such other institution for imparting training to students in the field of interaction in different languages, symbols and codes and to take affiliation from the universities in India and abroad for the technical and traditional fields like Science/Arts/Commerce/Computer education and other courses .
5. To provide educational services in the nature of short courses and vocational programmes , to foster industry partnerships including executive training and development workshops/programmes and to forge new partnerships and funding for enabling the required growth.
